

**You may attend this class as soon as your bankruptcy has been filed and you have obtained a bankruptcy case number**

As a convenience, especially for filers who live outside the Wichita area, classes are held on the same day as the “Section 341”, creditor, or Trustee hearings that will occur approximately 30 days after you file for bankruptcy. In addition, we have been advised that you must attend the class no later than 45 days after your hearing. Classes are also held on a selected evening and Saturday morning of every month. The fee for this class is \$25 per household, if joint filers attend together. Classes marked (WBA) will be held at the Wichita Bar Association, 225 N. Market, a short walk from the US courthouse in Wichita (see map). Class marked (CCCS) will be held at the Consumer Credit Counseling Service office in Wichita, 1515 E. Lewis, one block north of Kellogg, between Washington Ave. and Hydraulic. The certificate required as part of the paperwork needed for a bankruptcy to be discharged will be issued at the completion of the class.

**Please bring a government issued photo ID and your bankruptcy case number to the class.**
